# A. NCOE Foundation Monthly Financial Report

# C. NCOE Foundation Compliance Calendar

## D. NCOE Foundation 201-20 Tax Return and Form RRF-1

Mr. Schultz reminded the Board that a copy of the 2019-20 tax return 990-EZ and the completed Form RRF-1 are in the board packet. Mr. Schultz noted that 2019-20 was the first year the NCOE Foundation had enough money to file a full 990-EZ. Mr. Schultz further noted that the auditors for the NCOE, Christy White and Associates, are also the auditors for the NCOE Foundation, because the NCOE Foundation is considered a component of the NCOE with regard to reporting purposes for an audit. Mr. Schultz noted that going forward both the tax return 990-EZ and the Form RRF-1 will be filed by November 15 of each year.

# **E. Update Bill Dodd Fundraiser Distributions**

Ms. Sitch reported that in the most recent month, the childcare program had 126 students in the program and 85 percent of those students were on scholarship ranging from 10 percent to 100 percent. The program is thankful that the Bill Dodd funds will cover these scholarships. Ms. Sitch reported that she is working with Kelly Bucy regarding the logistics for additional disbursement of Bill Dodd funds.

Mr. Schultz recommended at some point to let the donors know what their funds have facilitated.

## F. **Goal Setting 2021-22**

Ms. McClure reported that the desire to have more support in reaching out to donors and attracting local funding participants in our board endeavors would help us with funding needs. Ms. McClure encouraged the board to work on their list of needs. The topic will be on the June agenda for further discussion.

Ms. McClure reminded the Board that the Fund Distribution Report will be included in the June board packet as a reminder that the reports are due in July. Everyone who had funds distributed will need to report and will also need to include a report back to the funders.
