## **B. Upcoming grants and opportunities**

Ms. Sitch reported that the Mariposa program was selected and will be featured under the Art & Culture section in the Give Guide. Ms. Sitch noted that contributions will go toward the work happening in collaboration with Ballet Folklorico as well as other art and cultural projects. Ms. Sitch will be presenting along with program coordinator, Vanessa Rubio, to the Napa County Board of Education in December to go over the major bullet points of the program. Ms. Sitch further noted that we wanted to be listed in the Give Guide for a number of years and are now able to do so because, as a requirement to participate, we needed to be a part of a foundation for a certain amount of time, and the NCOE Foundation has met this requirement. Additionally, Ms. Sitch said she would send, under separate cover, information regarding the program and how to contribute.

Dr. Apolloni reported that he will donate \$1,000 to the Give Guide to benefit the Mariposa program.

Ms. Sprinkle will provide consulting services on the development of a case for support for the NCOE Foundation for a flat fee of \$2,000. Ms. McClure noted that she has requested a planning session with Ms. Sprinkle, not as part of the Board meeting.

Ms. McClure will look into Ms. Sprinkle's availability and invite her to the next meeting to meet the Board. Thereafter, a date for a subcommittee planning session will be arranged.
